

## Notice at Collection

### The Gosch Auto Group

The purpose of this notice is to tell you 1) the categories of personal information to be collected from you, 2) the business and commercial purposes for collecting that information, 3) about your right to opt-out of the sale of your personal information, and 4) how to find our privacy policy. As used in this notice, “Personal Information” means information that identifies, relates to, describes, is capable of being associated with, or could reasonably be hyperlinked, directly or indirectly, with a natural person who resides in California (or a household having one or more California members), where the information is not excluded from coverage under the California Consumer Privacy Act (CCPA). Information excluded from CCPA coverage may be subject to separate privacy policies we maintain in compliance other applicable laws.
